

ORDINANCE NO. 2009-10-34

AMENDMENT TO REGULATIONS FOR RESIDENTIAL PARKING PERMIT PROGRAM. AN AMENDMENT TO THE ORDINANCE ESTABLISHING REGULATIONS FOR RESIDENTIAL PARKING PERMIT PROGRAM BY AMENDING SECTION 1.34.050 (B) AND SECTION 10.34.130.

PREAMBLE:

WHEREAS, the American Fork City Council passed an ordinance establishing Regulations for Residential Parking Permit Program on August 20, 2009 and September 22, 2009; and

WHEREAS, the City Council wishes to amend the parameters of the designated Residential Parking Permit Area to more accurately reflect the needs of both the residents and the community as a whole; and

WHEREAS, the City Council desires to include a penalty provision relating to the Revocation of Permit Section; and

WHEREAS, it is in the best interest of American Fork City residents that the City Ordinance entitled **REGULATIONS FOR RESIDENTIAL PARKING PERMIT PROGRAM** be amended as set forth herein;

NOW THEREFORE, be it ordained by the City Council of American Fork, Utah, that the **REGULATIONS FOR RESIDENTIAL PARKING PERMIT PROGRAM** be amended as follows:

Section 10.34.050 is amended to read as follows:

The following areas within the City have been specifically designated as “no parking” zones for anyone but residents of the area:

1. 600 East from 300 North to 640 North on the west side
2. 600 East from 300 North to the north property line at 420 North on the east side. Parking is not restricted on the east side of 600 East from the south fence of the high school to the north end of staff parking in front of the high school. Parking is restricted from the north end of staff parking to the north end of the Catholic Church property line
3. 620 North from 600 East to the end of the cul-de-sac
4. 600 North from 600 East to the end of the cul-de-sac
5. 550 North from 600 East to the end of the cul-de-sac

6. 520 North from 600 East to 550 East on the north side and from 600 East to the west property line at 568 East on the south side.
7. 400 North from 600 East to 630 East
8. 630 East from 300 North to 400 North.

Attached hereto as Exhibit "A" and incorporated herein by reference is a copy of a map that designates the restricted parking areas. If there is ever found to be a discrepancy between the map and the written language of this subsection, then the written language shall be superior.

Section 10.34.130 is amended to read as follows:

The City is authorized to issue a citation and immediately revoke the residential parking permit of any person found to be in violation of this chapter, and upon written notification, the person shall surrender the permit to American Fork City. Failure to surrender such permit shall be deemed an independent violation of this Chapter. If such residential parking privileges are revoked, the resident may be prohibited from obtaining any residential parking permit for one year.

This Ordinance shall be in effect upon its first publication.

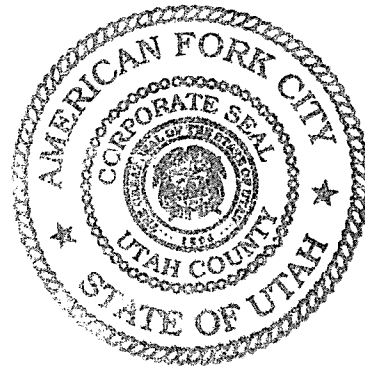


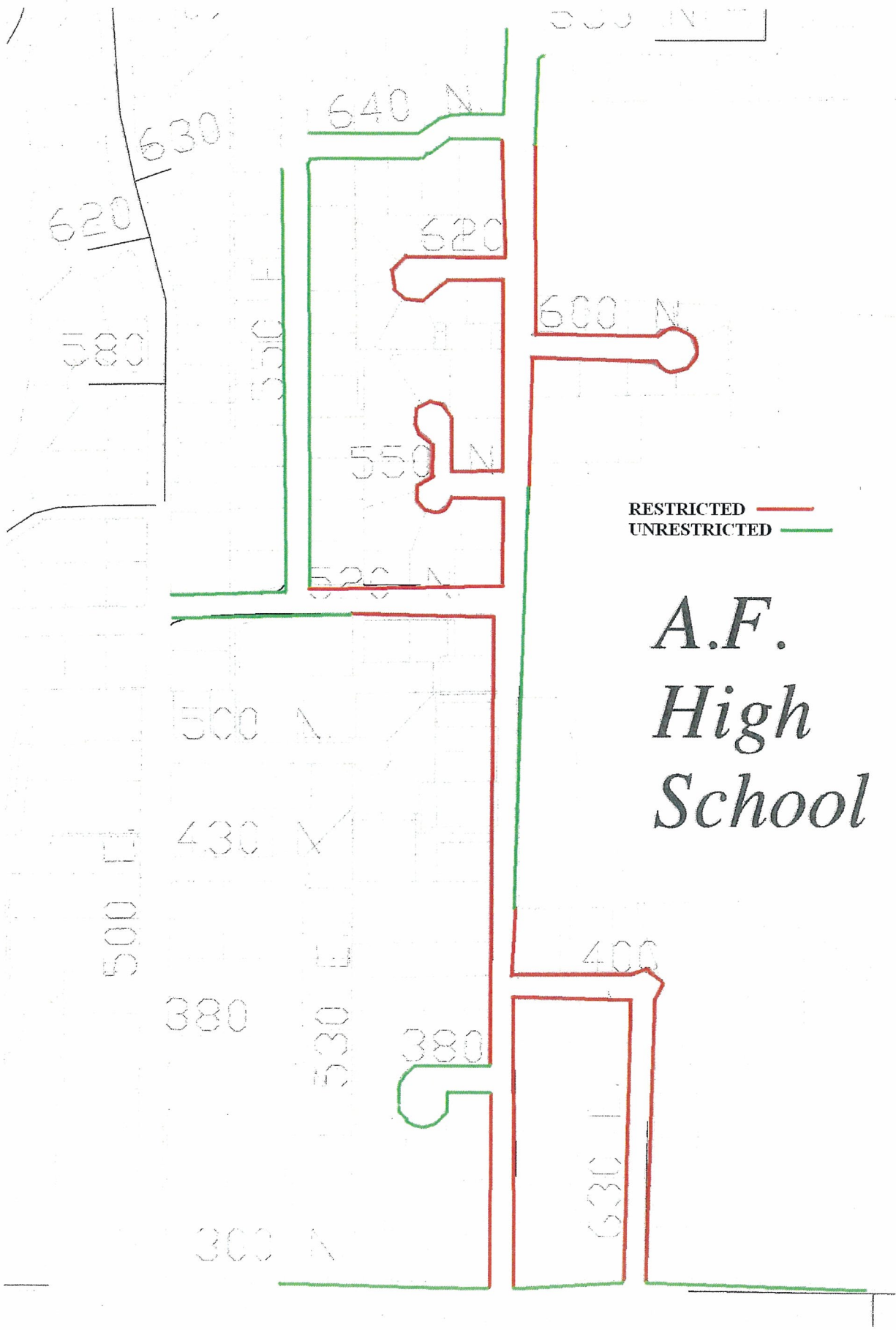
